An ATR has been filed by IO ASI Anil Kumar, PS Kanjhawala stating that "papers handed over to Kamal Kumar were found to be forged on scrutiny on which property dealer Vijay Singh was formally arrested on 20.3.2018 from Tihar Jail, who is undergoing JC since 22.3.2018. The witness Santosh Kumar has obtained anticipatory bail on 3.4.2018; however, he has not joined investigation. Soon the case will be put in the Court. Whereabouts of the plot owner Vikas Kumar are not known."

### 4. Directions of PGC

IO is present and stated that the remaining accused Santosh Kumar has been granted anticipatory bail by the court and he will be interrogated soon with regard to investigation in the
