**1. Brief facts of the complaint**

The complainant has filed a complaint against A SI Praveen & ASI Ashok Kumar for their non-cooperative behaviour. The complainant has alleged that several times she tried to know the status of her MLC but the alleged police officials never informed her the details and always rebuked her with the remarks “ go to judge, judge will take action, judge will tell you about your case.” She was also threatened of implicating her in a false case. She has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 17<sup>th</sup> January, 2018, the second hearing held on 7<sup>th</sup> March, 2018 and the third hearing held on 26<sup>th</sup> April, 2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

An ATR has been filed by SI Praveen Kumar, P.S. Ranhola, stating the following :-

- ii. It is further submitted that on 8.4.2014, EO ASI Ashok Kumar has arrested accused Shiv Shankar s/o Shri Ravinder Prasad (son of the present complainant) alongwith Mukesh Kumar

iii. It is further submitted that on 19.9.2014, IO S.I. Jasbir Malik arrested accused Shiv Shankar s/o Shri Ravinder Prasad (Son of present complainant), Sushila Devi wife of Shri Ravinder Prasad (present complainant) and (iii) Avdesh Kumar s/o Ravinder Prasad, all r/o H.No. G-37, Guru Dayal Vihar, Bakkarwala, Delhi vide FIR No. 406/14 u/s 325/34 IPC PS Ranhola, Delhi. “

#### **4. Directions of PGC**

The police representative present in the Commission has informed that the matter is already sub-judice and in the previous ATR by clerical mistake it was mentioned that Shiv Shankar, Avdesh and Sushila Devi were arrested on 19.9.2014 and 19.9.2015, whereas they were arrested on 19.9.2014 only.

As per mandate of the Commission, any matter which is sub judice cannot be taken up by the Commission for hearing. The Commission has, therefore, decided to close the case being sub judice, with the advice to the complainant to pursue the case in the Court of law.
