### **Background**

The appellant, vide his DRTI application dated 25.09.2017 has sought information on total 8 (eight) counts. Being aggrieved by the non receipt of information, the appellant filed this appeal.

The appellant had filed the present application before the Deputy Commissioner (Rohini Zone) / Competent Authority. However, the same was transferred to Deputy Commissioner (Keshav Puram Zone) due to change of jurisdiction of property in respect of queries were raised by the appellant.

### **Proceedings**

The appellant not present. Sh. K.R. Meena, A.E. (B), KP Zone, present on behalf of Competent Authority submitted that a reply had already been furnished to the appellant vide letter dated 08.06.2018. Reply perused.

On perusal of reply, it has been revealed that the department had provided satisfactory information in respect of Query Nos. 1, 2, 3, 4 and 7, hence no further action is required in the matter. In respect of Query Nos. 5, 6 and 8, the Competent Authority is directed to provide a comprehensive revised reply regarding details of house tax, plot size and guidelines / duty of J.E., A.E. & E.E (Bldg.).

The Competent Authority i.e. Deputy Commissioner (Keshav Puram ), North DMC, is directed to furnish revised comprehensive reply in respect of query Nos. 5, 6 & 8 within
