**1. Brief facts of the complaint**

Sh. I.M. Wadhawan has filed a grievance in PGC on 20.12.2017 regarding harassment and mental torture on account of non-payment of pensionary benefits since March, 2016.

The Commission has convened several hearings in the case starting from 8.2.2018.

**2. Facts emerged during the proceedings**

Shri Dinesh Jha, SDM-VI(HQ), Revenue Department, GNCTD informed that action on the grievances has been taken and accordingly amount of reimbursement of medical bills upto May, 2018 has been sanctioned. Further, Provisional pension has been revised in accordance with 7<sup>th</sup> CPC and 90% of Leave Encashment as per rules.

It was further informed by SDM-VI(HQ) that regarding non-issuance of chargesheet to the complainant, the status had been communicated to the complainant

vide letter dated 14.6.2018 stating that a decision has been taken by the ADM, Distt- West to discontinue the inquiry till the decision of the Court in the criminal case against him.

Copy the action taken report handed over to the complainant today by SDM-VI(HQ).

**3. Directions**

**In view of the above submissions and progress made by the Department in the matter and that the issue of non-payment of medical bills, revision of pension and Leave Encashment has been settled, the case is closed in the Commission. SDM-VI(HQ) to inform decision of the Court in the criminal case to the complainant.**
