1. Brief facts of the complaint

The complainant has filed a complaint of inaction against SHO/Sangam Vihar on his complaint of beating him and his family members by the area Councillor alongwith her associates. On 13.6.2017, area Councillor Urmila Yadav/s sons Ravi Yadav and Mohit Yadav alongwith their associates were using caste/religion derogatory words against Muslims to which complainant's son objected. Hearing this, they got infuriated and started beating his son brutally and also ransacked the shop and looted Rs. 12,000/-. When the complainant returned from mosque after offering prayer, he was beaten by one SI of PS Sangam Vihar who said to be niece of Urmila Yadav. The complaint was made at NO. 100 but no one turned up. He has also alleged that the SHO also misbehaved with them and were detained in the PS for the whole night without any reason. The complainant has requested for legal action in the matter.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 30^{th} January, 2018, the second hearing held on 27^{th} February, 2018, the third hearing held on 17^{th} March, 2018 and the fourth hearing held on 17^{th} April, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

The complainant is present and stated that police officials of PS Sangam Vihar misbehaved with him. He further stated that he was not present at the place of occurrence as he had gone to offer prayers-"Roza".

The complainant also claimed to be having in possession the video recording of the incident in support of his allegations but same has not been presented/submitted before the Commission so far.

4. Directions of PGC

The police representative present during the hearing informed the Commission that both the cases have been put in court for necessary legal action against alleged accused persons.

No incriminating evidence has emerged against the police personnel as alleged by the complainant, and the case investigation has been concluded. No meaningful purpose will be served by keeping the matter pending/enquiring into allegations against alleged officials in absence of any oral/material evidence. The Commission decides to close the matter.
