**1. Brief facts of the complaint**

The complainant has filed a complaint stating that on 10.8.2017, he alongwith Azhar Ahmad were standing near post office, Daryaganj. In the meantime SI S. Pritam Singh alongwith one Constable came over there and asked him ' as to why I did not visit P.S. Darya Ganj, Delhi'. He asked him about the reason for his visit to PS. It was disclosed that the said Azhar Ahmad had lodged a complaint against him and his partner Shri Zafar Ahmad for his alleged dues against Shri Zafar Ahmad. He told the police that the matter is civil in nature as such police has nothing to do. On this the said SI caught him forcefully and dragged him to take him to PS. However, after due persuasions and making payment of Rs. 1,000/- to SI Pritam Singh, by Anwar Ahmad, on his behalf, he was let free with instruction to visit him in PS Daryaganj , Delhi after 15.8.2017. The complainant has further alleged that he may be implicated in a case criminal case by the said SI at the instance of Shri Azhar Ahmad. The complainant has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 8<sup>th</sup> November, 2017, the second hearing held on 17<sup>th</sup> January, 2018, the third hearing held on 14<sup>th</sup> March, 2018, the fourth hearing held on 11<sup>th</sup> April, 2018 and the fifth hearing held on 9<sup>th</sup> May, 2018, when the following were present:-

### **3 Relevant facts emerging during the hearing**

An ATR has been filed by Addl. DCP-I, Central District through SI Sumit Kumar, Vigilance/Central, stating that “as recommended by the Commission, on 19.4.2018, the undersigned personally met the complainant and heard him in person. He explained his grievances and thereafter the matter was got enquired through ACP/PG Cell/Central. During enquiry, the allegation of taking Rs. 1000/- by the Sub-Inspector could not be substantiated but the allegation regarding misbehaving and manhandling with the complainant could not be ruled out. In response to the SCN, SI Pritam Singh has submitted his reply and he was also heard in person but the plea putforth by him was not found convincing. Hence, SCN for censure issued to SI Pritam Singh, No. 6205-D vide No. 1486-89/HAP(P-1)/C dated 06.04.2018 has been confirmed and he has been awarded punishment of censure vide no. 2408-18/HAP/P-1/C dated 7.5.2018.”
