1. Brief facts of the complaint

The complainant has filed a complaint stating that he was coming from his factory to home by walk. In the way near Sultanpuri bus stand, two persons came from behind on white scooty and they stopped him without any reason and started quarrelling with him. He alleged that they put their hand in his pocket and threw all his valuables like two pan cards, two debit cards, licence, metro card and Rs. 20,300/-. AS he saw thils, he protested and tried to save his money. The alleged frustrated due to his protest and one of them asked other to kill him with knife. He called at NO. 100. PCR came within few minutes. He showed the incident point to PCR police persons. PCR asked him to reach in PS Sultanguri. (Incident time 10:45 +-10 minutes and Dated 23 August 2017). He reached PS and wrote his complaint. He alleged that after reading his statement, police refused it and asked him to come at next day in the morning. He reached in PS in morning the next day. Mr. Balwant took him to SHO. SHO harassed him and threatened him in his room. As the complainant came outside, he told Balwant that he did not want to give any statement. Then Mr. Balwant stopped him and wrote his complaint in his way. He asked to provide receipt but he did not provide him and asked asked him to come later. He also stated that after one day of this incident happened, a person came his home and gavehim all card, license etc. except Rs. 20,300 and one pan card. The complainant has also alleged that he told the police person that they can catch the culprit because CCTV was there where the incident took place, but they are not serious/sensitive to take action against the alleged persons. The complainant has requested for legal action in the matter.
