# 1 Brief Facts of the Complaint

The complainant has filed a complaint in PGC regarding inaction against Delhi Police on her complaint of misbehaviour and molestation against a boy named Ravi residing in the same building. She has also alleged that instead of taking action against the alleged, SI Suresh threatened her and pressurized her for compromise.

# 2. Facts emerging during the proceeding

An ATR has been filedby Inspector Tej Pal Singh, SHO/PS Jehangirpuri, stating that "the complainant Ms. Kirti @Mona was called and during enquiry she gave in writing that now she is residing at B-1486, Jehangirpuri alongwith her mother. On 8.6.2018, due to some misunderstanding her mother made a PCR call against Ravi s/o Ram Singh r/o G-1803, Ground Floor& top floor, Jahangirpuri,Delhi and her relatives also lodged a online complaint in this regard, but no incident of molestation was occurred with her. She does not want any police action on her complaint.Statement of the complainant is attached herewith. ATR further stated that during enquiry, no cognizable offence or any lapse on the part of SI Suresh Kumar was found. No need of any police action on the said complaint. Complaint may be filed please."

# 3. <u>Directions of PGC</u>

Inspector Tejpal, SHO/PS Jehangir Puri is present and filed a status report. He stated that no offence of molestation or misbehaviour was found. He further stated that the matter has been resolved amicably and attached a written statement of the complainant with the ATR.

The Commission perused the written statement stating that she (the complainant) does not want any police action on her complaint.
