**1. Brief facts of the complaint**

The complainant has filed a complaint stating that her daughter who is studying in class –VII has been missing since 23.10.2017. A case was registered vide FIR No. 664, dated 24.10.2017 u/s 186, 363, PS Dabri. She further stated that she is visiting daily to PS Dabri but the police officials are not taking any action to trace her daughter. She alleged that police officials say that responsibility to trace her child is her as the girl has eloped with someone. Even they have not taken statement of her neighbours or visited the site. She also alleged that IO of the case Komal Singh does not speak properly and comments inappropriately about character of her daughter. The complainant has requested for necessary action in the matter.

**2 Facts emerging during the proceeding**

An ATR has been filed by ASI Kamal Singh, PS Dabri, stating that “a case vide FIR No. 664/17 u/s 363 IPC has been registered in PS Dabri. During investigation the prosecutrix Archana d/o Sanjay Paswan, r/o B-1/94, Madhu Vihar, Delhi, age 16 ½ years has been recovered on 11.7.2018 and got medically examined from DDU Hospital, Hari Nagar and statement u/s 164 Cr.P.C. was also recorded in the court and section 366-A & 4 POCSO Act added in this case. The prosecutrix was sent to Nari Niketan, Nirmal Chhaya, Hari Nagar, Delhi on 12.7.2018. The accused Shahzad was arrested and sent to J/C. The investigation of the case has now been entrusted to W/SI Suneeta and the same is pending with her.”

**3. Directions of PGC**

**As per the ATR, the missing girl has been recovered and the accused has been arrested and sent to J/C.**

**Thus, with the intervention of the Commission, the grievance of the complainant has been redressed by the police by recovering her missing daughter and arresting the accused. Hence, the Commission**
