**1. Brief facts of the complaint**

Shri Rajender filed a grievance in PGC on 15.03.2017 regarding illegal advertising board at Mayur Vihar, DND Toll Plaza.

**2. Proceedings in the Public Grievances Commission**

**3. Relevant facts emerging during the hearing**

3.1 At the last hearing held on 7<sup>th</sup> May, 2018 the directions of the PGC were as follows :

Commercial Officer, EDMC is directed to examine whether these advertisement boards were unauthorizedly placed on the Govt. land? If yes, these people have trespassed on Govt. land, earned profits and evade the Govt. taxes. A FIR may be lodged against them for causing revenue loss to the Govt. and submit an Action Taken Report on the next date of hearing.

Asstt. Director, Vig., EDMC is directed to complete the action in the matter and submit a report on the next date of hearing

3.2 Shri Vineet Gautam, AO (Advert.), EDMC is present in the hearing and informed that the land under question has been leased to DND Flyway and hence MCD cannot charge Monthly

License Fee from the vendor, whose advertisement was put on the land and only tax can be levied. He further information that there is a High Court Order wherein it has been directed that Monthly License Fees charged in the past should be refunded.

3.3 A copy of the orders mentioned above has been submitted by him in the Commission, as directed.

**4. Directions of the PGC**

**As required action in the matter has been taken by the EDMC and no further action is needed, the matter stands closed at the level of PGC.**
