#### 1. Brief facts of the complaint

Sh. Gyan Chand Gautam filed a grievance in PGC on 14.07.2017 against illegal construction and encroachment on public land done by one Shri Kamal Bijli Wala at H.No. 130/1, sudarshan Road, Gautam Nagar. New Delhi in the form of construction of ground floor plus 5 storeys, without getting the sanctioned building plan.

# 3. <u>Relevant facts emerging during the hearing</u>

3.1 At the last hearing held on 18<sup>th</sup> April, 2018, the directions of PGC were as follows :

Sh. Manish Huria, AE (B), South Zone, SDMC is directed to complete the action in the matter and submit an Action Taken Report on the next date of hearing.

3.2 Sh. A.K.Jain, JE (B) is present in the hearing and submitted a status report stating that ;

In furtherance to report placed before this Hon'ble Commission on 18.4.2018, it is submitted that during the course of action, as scheduled for 28.05.2018 there demolished chajja / projection at

second floor, third floor and fourth floor of the right hand side portion of the property under reference. Now, further action as per law will be taken in due course of time.

3.3 ASI D.S.Chauhan, P.S. Hauz Khas is present in the hearing and submitted a report stating that :

It is submitted that Sh. Gyan Chand Gautam filed a grievance in PGC on 14.07.2017 against illegal construction and encroachment on public land done by one Sh. Kamal Bijli Wala at H.No. 130/1, Sudarshan Road, Gautam Nagar, New Delhi.

On last hearing held on 7<sup>th</sup> Mar. 2018 PGC directed DCP (South)/SHO (Hauz Khas) to made available the adequate police force as and when they are approached by the SDMC for the demolition of the building under reference.

In this regard on 17.4.2018 and 28.5.2018 JE, SDMC, Mr. A.K.Jain along with staff approached police station Hauz Khas for police force and thus adequate police force was provided on both dates as required.

3.4 The complainant is not present in the hearing but has submitted a representation requesting for closure of complaint as the SDMC has taken action on his complaint to his satisfaction.

# 4. Directions of the PGC

Action in the matter has been taken to the satisfaction of the complainant. The matter stands closed at the level of PGC.
