**1. Brief facts of the complaint**

The complainant has filed a complaint in PGC stating that on 17.11.2017 at about 7-7.30 p.m., an incident happened with his daughter i.e. she was beaten, rape attempted and her gold ear ring alongwith Rs. 5000/- were snatched from her for which several calls were made at No. 100, but no one came to the spot even no police official came during the MLC. He further stated that when they reached to PS Pandav Nagar, they did not find any lady police officer on Women Help Desk to whom his daughter could give her complaint. They tried to contact SHO but could not succeed as he (SHO) refused to meet with them, and after waiting around one hour, IO H.C. Lalit came to Police Station and he requested the IO to record his daughter's statement but he shouted on him and used unparliamentary language. The complainant has requested for legal action against the IO HC Lalit, and all culprits who are involved in crime so that his daughter may get justice.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 5<sup>th</sup> February, 2018, the second hearing held on 12<sup>th</sup> March, 2018, the third hearing held on 16<sup>th</sup> April, 2018, the fourth hearing held on 1<sup>st</sup> May, 2018 and the fourth hearing held on 28<sup>th</sup> May, 2018, when the following were present:-

**3     Relevant facts emerging during the hearing**

An ATR has been filed by HC Lalit Kumar, PS Pandav Nagar, stating that the case vide FIR NO. 669/17, dated 26.12.2017 was registered at PS Pandav Nagar, Delhi on the complaint of the complainant. Investigation of the case is on progress but yet to be completed. Detailed status report has already been filed. Further, it is submitted that on 2.5.2017 accused Sahil was summoned before the concerned court, where he was arrested after the written permission of Hon'ble Court and on the same day he was released on court bail. Investigation has been completed in all respect. Draft challan is also prepared but it will be send for scrutiny very soon."

**4.     Directions of PGC**

**SI Gunjan Singh is present and stated that both the accused have been arrested and are on bail by the court. The investigation in the case is complete and chargesheet will be filed within two weeks. The complainant is not present. He has not attended any of the five hearings held in the Commission so far.**

**IO is directed to inform the complainant about the progress of the investigation preferably in person, file a chargesheet in the court within two week and send an ATR in the Commission by 20<sup>th</sup> June, 2018 for its information.**

**With the above advice, the Commission has decided to close the case in PGC.**
