## 1. <u>Brief facts of the complaint</u>

The complainant has filed a complaint alleging that on 13.12.2017 one Manjit allured her 15 years old daughter and took her away to some unknown place. She gave information to PS Nangloi in this regard. Police registered a case vide FIR No. 518/17 u/s 363 IPC. She alleged that IO Bhagwati Prasad, ASI did not make any effort to trace her. IO also abuses her and her son. She further alleged that IO called her son at PS on 26.2.2018 and made him sit in PS for 5-6 hours. The complainant has requested for necessary action in the matter.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 16<sup>th</sup> May, 2018, when the following were present:

An ATR has been filed by IO/ASI Bhagwati Prasad, stating that "on behalf of complaint of Smt. Kalawati wife of Shri Surender Singh, r/o A-144, Arvind Enclave, Nangloi, Delhi, a case FIR vide No. 518/17 u/s 363 IPC P.S. Nangloi has been registered and appropriate legal action has been taken by local police and missing girl namely Anjali have been recovered on 23.4.2018 from her aunty (Mausi) house and her statement u/s 164 Cr.P.C. have been done before Hon'ble Court of CWC and missing girl Anjali handed over to her parents. It is also submitted that missing girl has been recovered by the best efforts of local police and at present she is residing with her parents."
