### 1. Brief facts of the complaint

Sh. Sanjeev Jain filed a grievance in PGC on 03.01.1017 regarding illegal construction in property No.A-1/66A, Sewak Park, Uttam Nagar, New Delhi.

## 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has convened nine hearings since 20.03.2017 in the matter and at the last hearing held on 6<sup>th</sup> June, 2018 the following were present:

### 3. <u>Relevant facts emerging during the hearing</u>

3.1 At the last hearing held on 2<sup>nd</sup> May 2018, the directions of PGC were as follows :

Shri A.K.Gupta, AE (B), West Zone stated that the property under question appears to have been constructed 4-5 years back and the same may attract protection under the National Capital Territory of Delhi Laws (Special Provisions) Second (Amendment) Act 2014.

However, no credible evidence is available with MCD to suggest that building has been constructed prior to 2014. Therefore, in the absence of any documentary evidence it's difficult to accept the same on face of it.

Sh. A.K. Gupta, A.E. is directed to physically inspect the building personally, seek necessary evidence of construction having taken place prior to 2014 and submit his report with supporting documents.

In the absence of any credible evidence to suggest construction took place prior to 2014, the action be initiated against the property for illegal / unauthorized construction as per DMC Act.

Ex. Engineer (B)-II, West Zone, SDMC is directed to ensure action accordingly and submit an Action Taken Report on the next date of hearing.

3.2 Sh. R.D.Chaudhury, AE (B), West Zone is present during the hearing and submitted a report stating that :

In compliance of the directions of Hon'ble PGC, the undersigned visited the property in question on 01.06.2018, where, the owner of t he property Sh. Mallu Ram Jakhar met. From the inspection, the property appears to be old, however, the owner also shown some documents / letters confirming the year of construction and informed the same will be submitted officially on the next working day. The following documents have been submitted by the owner on 04.06.2018 vide diary No. 1573/II/G
