1. Brief facts of the complaint

Sh. Karamchand Tyagi filed a complaint in PGC on 22.08.2016 regarding non-demarcation of land in Village Salempur Mazra and Village Burari by the Tehsildar (Civil Lines).

2. Proceedings in the Public Grievances Commission

The PGC has convened thirteen hearings in the matter and at the last hearing held on 24th May, 2018 following were present:

3. Relevant facts emerging during the hearing

3.1 During the hearing on 24th April, 2018 the directions of the PGC were as under :

As per record the complainant has filed complaint with this Commission on 4.7.16 regarding demarcation of land bearing Kh.No. 28 & 29 in Village Burari. Even after 1 year 8 months nothing has happened on ground and it is shocking that decisions which can be taken and relief could have been granted to the local villagers, is being passed on at the level of the Commission by the senior officers of the administration. Sh. Satish Kanojia, Tehsildar, Civil Lines is directed to ensure that the demarcation be completed within a period of one month failing which the Commission will be constrained to recommend enquiry and punitive action against the concerned officials.

District Magistrate (North) is advised to ensure that the demarcation is completed in a month's time and the Tehsildar Civil Lines is present in person on next date of hearing.

3.2 Shri Satya Prakash, Patwari is present during the hearing and submitted a report stating that :

As per direction of the Hon'ble PGC a demarcation of land situated at Kh. No.11/20/1/2 Village Salempur Majra, Burari f Sh. Karam Chand Tyagi has been carried out, in the presence of both the parties (copy of karyawahi nishandehi is enclosed herewith). None of the party raised objection for the demarcation carried out on 2.5.2018.

In view of the above the Hon'ble Commission is requested to close the matter.

4. Directions of the PG

Demarcation done by the Revenue Department officials to the satisfaction of the complainant. The matter stands closed at the level of PGC.
