**1. Brief facts of the complaint**

The complainant has filed a complaint alleging that his wife, father-in-law and mother-in-law use to beat him and police did not take any action against them. He also alleged that police officials of PS Harsh Vihar arrested and beat him. He also stated that SHO demanded money and other police personnel used caste related derogatory words to him. He has requested for legal action against the alleged persons.

**2. Relevant facts emerging during the proceeding**

An ATR has been filed by Addl. DCP-I/North East District stating the following is on record :-

After marriage, frequent quarrel between husband-wife and both family started on domestic issues. Complainant leveled allegations of beating, threat of killing and use of caste related derogatory words against his father –in-law.

Both the parties made PCR calls and complaints of such allegations. Complainant filed similar complaint which was enquired into by PG Cell/NED.

On 24.1.2018, PCR call regarding quarrel was marked to SI Sanjay who filed the same being matter between husband and wife. After that again PCR call was received in PS at 10 p.m. on which action u/s 107/151 Cr.P.C. against Bhoop Singh was taken and on medical examination, no fresh injury mark was found on the body of the complainant. The complainant stated that when police personnel and his father-in-law used caste related derogatory words but could not produce any witness saying that no person other than them was present there. ASI Devender Singh tried to get the statement of the complainant for taking necessary action on MLC but he did not give his statement. He stated that his known stabbed him at about 10-11 a.m. whereas he made PCR call in this regard at 7.10 p.m. and prepared his MLC NO. 32702 at 9.50 p.m. Thus, it is evident that complainant's PCR call and MLC was after thought.

Enquiry also revealed that complainant has filed a complaint u/s 156.3 Cr.P.C. in KKD Courts. The audio CD provided by the complainant does not prove the allegations of threat. The allegations leveled by the complainant could not be substantiated.”

**4. Directions of PGC**

**As per the ATR, the complainant has already filed a complaint u/s 156 (3) Cr.P.C. in the Court in the similar matter. Thus, the instant matter is sub-judice.**

**Given the mandate of the Commission that any matter which is sub judice in nature cannot be taken up for hearing, the Commission has decided to close this case with the advice to the complainant to pursue his matter in the Court of law. SHO, Harsh Vihar shall file a factual report before the Magistrate in the matter as and when matter is listed before the Magistrate.**

**With the above advice, the matter stands closed in the Commission.**
