**1. Brief facts of the Appeal**

Shri Vinod Kumar filed Form-A during September, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Director (Primary Education), Education Department, East DMC, seeking information on total 1 count.

Shri Vinod Kumar did not receive a response from the Office of Director (Primary Education), Education Department, East DMC, hence, he filed an Appeal during November, 2017 before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.
