# 1. <u>Brief facts of the complaint</u>

The complainant has stated that his daugther, namely, Manju married, with Pramod Kumar, s/o Shri Om Prakash, r/o B-81, Hari Enclave, Kirari, Suleman Nagar, Delhi on 7<sup>th</sup> May, 2014. His son in law was an addict of liquor and died on 18<sup>th</sup> August, 2016. At that time his daughter was pregnant. During delivery, the in-laws of her daughter did not take care of his daughter and she died during delivery on 17.9.2016. The complainant has requested for necessary action in the matter.

### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 16<sup>th</sup> March, 2017, the second hering held on 18<sup>th</sup> May, 2017, the third hearing held on 20<sup>th</sup> July, 2017, the fourth hearing held on 21<sup>st</sup> September, 2017, the fifth hearing held on 23<sup>rd</sup> November, 2017, the sixth hearing held on 1<sup>st</sup> February, 2018, the seventh hearing held on 8<sup>th</sup> February, 2018, the eighth hearing held on 8<sup>th</sup> March, 2018, the ninth hearing held on 26<sup>th</sup> April, 2018 and the tenth hearing held on 17<sup>th</sup> May, 2018, when the following were present:-

## 3 Relevant facts emerging during the hearing

Neither an ATR has been filed nor anyone from PS Sultanpuri is present. As a result, today's proceedings in the Commission has become infructuous. The Commission has taken a serious view for non-presence of the concerned police representative and non-filing of an ATR.

### 4.. Directions of PGC

After the hearing was over, SI Shrawan Kumar came in PGC and filed an ATR stating that final subsequent opinion on post mortem of deceased Manju d/o Babu Lal has been obtained from BSA Hospital,Rohini. The doctor has opined that "the death was likely to have been caused by hemorrhagic shock consequent to normal delivery i.e. post partum hemorrhage-a natural cause." That,there isnothing adverse found in the death of deceased. As the allegations made by the complainant Babu Lal could not be substantiated."

The Commission observed that the complainant has not been attending hearing in the Commission for the last 6-7 hearings. It appears that he is not interested in pursuing his case in PGC.

In view of the above, the Commission has decided to close the case in PGC.
