**1. Brief facts of the complaint**

The complainant has filed a complaint against Delhi Police of beating and illegal detention. He has stated that on 27.12.2017 at around 11.00 p.m. a quarrel took place between a rickshaw pullar and bullet motor cycle riders. He intervened in t he matter and called at No. 100 . The police turned up in pursuant to the call and made false allegations against the complainant of abusing the police officials and took the complainant and his son to police station Paharganj and detained them till 3.00 a.m. He has alleged that the police favoured the motor cycle rider and brutally beaten the complaiantn and his son publicaly. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 7<sup>th</sup> March, 2018, the second hearing held on 18<sup>th</sup> April, 2018 and the third hearing held on 16<sup>th</sup> May, 2018, when the following were present:-

Respondent : SI Pushendra Singh, PS Paharganj

**3 Relevant facts emerging during the hearing**

On the last date of hearing, the complainant was not present and “he was directed to be personally present in today’s hearing, failing which the Commission will be constrained to close his case.” In today’s hearing also, the complainant is not present. He has not attended any of the three hearings held in the Commission. It appears that he is not interested in pursuing his case in PGC.

As per the ATR filed by police, the allegations against the police officials could not be substantiated. Apart from this, SI Pushendra stated that the complainant was engaged in charging the e-rickshaw batteries that is why was insisting for registration of a case against the motor cycle riders.
