**1. Brief facts of the complaint**

The complainant has filed a complaint of inaction on his complaint made to various police authorities. He has alleged that he made a complaint to DCP/Civil Lines who asked the concerned SHO to take action on it. He has further alleged that he was called by the SHO and abused him in filthy languages. He also threatened him to send him behind the bars and pressurized him to compound the matter with the offenders. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 18<sup>th</sup> January, 2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

**An ATR has been filed by Addl. DCP-I/North District through SI Deepak, PS Kotwali, stating the following :-**

- i. Enquiry got conducted into the matter through ACP/PG Cell has revealed that on 18.2.2016 Smt. Daljeet Kaur lodged a complaint against Sita Ram Mishra (complainant) alleging that he misbehaved and proposed to marry her. He also abused and beat her on denial.

Further during patrolling, HC Gyan Parkash found SitaRam Mishra quarreling with Smt. Daljeet Kaur(alleged person) and arrested him u/s 107/151 Cr.P.C. His belongings, blamed to be stolen by Daljeet Kaur were in fact seized by HC Gyan Parkash during his personal search conducted while arresting him u/s 107/151 Cr.P.C. The complainant has corroborated his allegations leveled in the complaint and stated that he was forced to compromise the matter and beaten in Police Station. HC Gyan Parkash stated that on 2.3.2016, he arrested complainant Sita Ram u/s 107/151 Cr.P.C. and deposited the articles including mobile phone, an Adhar Card, a black colour bag and a blanket seized in personal search. SHO/Kotwali stated that enquiry into the complaint of Sita Ram Mishra was conducted and found false and baseless. In fact the complainant lodged a complaint in retaliation to the fact that he was arrested u/s 107/151 Cr.P.C. on the complaint of Daljeet Kaur. SI Deepak also stated similar facts in his statement.

- ii. It is revealed from the facts that the complainant was produced in the Court of SEM/N on 3.3.2016. He pleaded guilty and was bound down to keep peace and public tranquility for a period of one year on a Personal Bond of Rs. 5,000/- and the conduct/gesture of the complainant towards Daljeet Kaur amounts to his sexual advancement towards her. No more action is warranted on his complaint."

#### 4. Directions of PGC

In view of the above, the Commission has decided to close the case in PGC.
