1. Brief facts of the complaint

The complainant has filed a complaint alleging that Vishal, Chand Babu, Nazim, Nanhe and Ansar kidnapped her daughter Shazia, aged 16 years. He stated that he gave the information regarding kidnapping of her daughter to PS on 9.1.2018 and FIR was lodged vide NO. 17/2018 PS Uttam Nagar. He

alleged that ASI and SHO/Uttam Nagar did not take any action in the matter.

2 Relevant facts emerging during the hearing

SI Anup Rana, Investigating Officer in the case stated that investigation in the case has been concluded and based upon the investigation; a cancellation report has been filed in the Court of ACMM, Dwarka. The same is pending before the Court as the complainant Abid Ali has sought time to file the protest

petition.

On 18.7.2018, the complainant alongwith his counsel appeared before the Hon'ble Court and raised some objections verbally and sought time to file protest petition in the Court. The matter was fixed for 17.8.2018 and again on 17.8.2018, the complainant appeared in person in the court and sought time to

file the protest petition. The matter has now been fixed for 4.10.2018.

He further informed that direction of the Commission were discussed with Public Prosecutor and other senior officers. The complainant has already engaged private counsel for himself and as far as the medical examination of the girl Sazia is concerned, she had already been medically examined in DDU

Hospital vide MLC NO. 1858.

3. Directions of PGC

The matter is now pending with the Court of ACMM, Dwarka Court regarding cancellation of the case and complainant has also been present before the court in the matter on last dates. Since proceedings cannot be simultaneously held in the Commission as per mandate of the PGC, the matter
