#### **GOVT. OF NATIONAL CAPITAL TERRITORY OF DELHI**

### 1. Brief facts of the complaint

The complainant has filed a complaint of helping the accused persons, namely, Karamvir Singh, Rameshwar, Ravi, Babli @ manju, Aarti etc. against ASI Sandeep, PS Kalyanpuri. She has stated that her minor daughter, aged 14 and half years was abducted/kidnapped on 21.2.2018 while she was going to school. The complainant while called for briefing the incident in the Commission on 25.4.2018 stated that though her daughter was recovered on 25.2.2018 she was re-abducted by the same persons from her own house while her daughter was there with her ailing/infirm father. She also stated that the alleged persons had given a threat in this regard of which she had intimated the police. She stated that the police has not taken any action in the matter. She has requested for recovery of her daughter and legal action against the accused persons.

## 2 Relevant facts emerging during the hearing

Insp. Rita Gera, present from DIU East informed that case FIR No. 384/18 u/s 363 IPC, PS Kalyanpuri was registered on the complaint of Shri Mahesh Saxena. Combined raid was conducted at village Bagwas, District Kasganj, PS Sikanderpur, UP by between DIU/East and PS Kalyanpuri to trace the kidnapped girl in case FIR No. 384/18. During raid kidnapped girl was traced and other accused were arrested in all the three cases (FIR Nos. 75/18, 149/18 and 384/18). The statement u/s 164 Cr.P.C. has been recorded again in the Hon'ble Court. All the accused are running in J/C. SHO/Kalyanpuri has briefed the beat staff to pay regular visit to the complainant, once a week, to instill confidence in the mind of the complainant so that they could not cause any harm to her and her children.

### 3 Directions of PGC

The complainant is present and expressed her thanks to the Commission and also the police for its concerted efforts in tracing her daughter.

The Commission directs the police to arrest the remaining accused. Whenever the accused persons are released from J/C, police shall keep watch over the accused persons and their activities. Additionally, police to arrange counseling of minor girl child through professional counsellors.

DCP/East District to write to Kasganj police for getting the antecedents of the accused persons scrutinized /verified, to rule out any possibility of their involvement in trafficking of girl children.

With the above directions, the grievance stands closed in the Commission.
