**1. Background :**

Sh. Rinku, the appellant vide DRTI application dated 16.01.2017 has sought information on total 07 counts. Being aggrieved with the information furnished, he filed the appeal before the Commission.

**2. Proceedings**

The applicant is not present.

Dr. Pramod, DHO and Sh. Virender, APHI are present on behalf of the Competent Authority and submitted a reply dated 10.08.2018.

The Appellate Authority / Member (PGC) notes that vide hearing order dated 24/08/2017, the Deputy Commissioner (City SP Zone), North DMC, had been directed to furnish a revised reply in respect of query no. 7 to the appellant. Vide reply dated 10.08.2018 the department informed the appellant that "since the HTL is old one and not available in the department. Hence, the information regarding the size of the shop at the time of obtaining the HTL is not available at this point of time".

The above reply of the department had already been discussed in detail during the hearing on 24.08.2017 and directions were given to the Competent Authority in respect of the information to be provided to the appellant.

But in today's hearing, no satisfactory information has been provided by the department as directed vide order dated 24.08.2017.

It is pertinent to mention here that the present appeal is pending before the Appellate Authority / PGC for nearly one year, on account of not furnishing the information in respect of Query No. 7.

Representative of the department assured that the revised reply, as discussed during the hearing will be furnished to the appellant within 10 days.

### **3. Decision**

**The matter is brought to the personal attention of the Competent Authority i.e. Deputy Commissioner (City SP Zone), North DMC.**

She is hereby directed to furnish the pointwise revised reply in respect of Query No. 7 directly to the appellant within 7 days from the date of issue of this order with a copy marked to the Commission. The reply should be furnished to the appellant under the signatures of Competent Authority, duly stamped, having the name of Competent Authority.

**With the above directions, the appeal case is closed at the Commission's end.**
