## 1. **Brief facts of the Appeal**

Shri Vinod Kumar filed Form-A during October, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Director (Personnel), CED, North DMC, seeking information on total 1 counts.

Shri Vinod Kumar did not receive a reply from the Office of Director (Personnel), CED, North DMC, hence, he filed an Appeal during November, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

## 2. **Proceedings in the Public Grievances Commission**

The PGC has convened its first hearing on 14<sup>th</sup> May, 2018. At today's hearing on 14/05/2018, the following were present:

3. Relevant facts emerging during the hearing

3.1 During the hearing on 14/05/2018, Sh. R.K. Madaan, S.O., informed that the requisite

information has already been provided to the appellant vide letter dated 20/12/2017. A copy of

the same is placed in the file.

3.2 The information supplied by the department has been perused and it has been observed

that the department had provided satisfactory information, however the same has not been

signed by the Competent Authority i.e. Director (Personnel), North DMC.

3.3 Representative of the department submitted that in respect of the application filed under

RTI Act-2005 by the appellant on the same questions, the appellant has inspected all the

available record and provided photocopies of the documents, free of cost, as asked by him. He

further submitted that one file has been missing and the enquiry regarding the same has already

been pending. He further stated that no other record pertaining to the matter is available with

the department.

3.4 The appellant on the other hand stated that he is not satisfied with the information

provided by the department, however he admitted inspection of the record and admitted that he

had received documents from the department.

4. Directions of the Appellate Authority / PGC

4.1 Since the department had provided satisfactory information to the appellant, no further

action is required in the matter. However, Competent Authority i.e. Director (Personnel),

CED, North DMC is directed to furnish a revised reply to the appellant, duly signed by

the Competent Authority, properly stamped, having the name of the Competent

Authority, within 15 days from the date of issue of this Order with a copy to the

Commission.

With the above observations and directions, the present appeal case is ordered to
