1. Brief facts of the Appeal

Ms. Pushpa sought information, during December, 2016, from the Competent Authority under Delhi RTI Act, 2001, i.e Deputy Commissioner (Shahdara North Zone), East DMC, seeking information on total 10 queries.

Ms. Pushpa did not receive a reply from the Office of Deputy Commissioner (Shahdara North Zone), East DMC; Hence, he filed an Appeal during February, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. <u>Proceedings in the Public Grievances Commission</u>

The Public Grievances Commission has so far convened three hearings on 15th May, 2017, 21st September, 2017 and 10th May, 2018. At the hearing on 10/05/2018, the attendance was as follows :

3. <u>Relevant facts emerging during the hearing</u>

3.1 At the last hearing held on 21/09/2017, the directions of PGC were as follows:

"The Competent Authority i.e. **Deputy Commissioner (Shahdara North Zone), East DMC** is directed to ensure that comprehensive, point-wise information / reply is to be provided to the appellant before the next date of hearing <u>under his signature</u>, with a copy to the Appellate Authority.

The reply should be furnished to the appellant under the signatures of Competent Authority, properly stamped, having the name of the Competent Authority (documents, if any, appended with the reply should be certified either by the Competent Authority or an official deputed by the Competent Authority).

A senior representative shall be deputed to attend the next hearing in this appeal case, with a reply (in duplicate)".

- 3.1 At today's hearing representative of the department informed that a revised reply duly signed by the Competent Authoroty had already been sent to the appellant vide letter dated 03.05.2018. He submitted a copy of the same before the Appellate Authority / Member (PGC). Representative of the appellant submitted that he has not received the reply. A copy of the same was given to him during the hearing.
- 3.2 The reply furnished by the department has been perused and it is found that the department has provided satisfactory information to the queries raised by the appellant in his DRTI application.

4. Directions of the Appellate Authority / PGC

Since the department has provided satisfactory reply to the queries of the appellant, no further action needs to be taken in this regard. Accordingly, the present appeal case is ordered to be closed before the Appellate Authority / Member (PGC).
