## **1. Brief facts of the complaint**

The complainant has filed a complaint stating that on 5.3.2017, Kundan, Chandan and their maternal uncle Sanjay who is posted in PS Nihal Vihar as Head Constable had beaten him and broken the articles of his office. They also took Rs. 35,000/- and one gold ring. On his complaint, a case vide FIR No. 88/17 was registered. When he lodged a complaint in PS about Rs. 35,000/- and gold ring, the same was not added in the FIR. The complainant has requested to inform the present status of his case as well as his complaint for stolen of Rs. 35,000/- and gold ring. The complainant has requested for legal action in the matter.

## **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 16<sup>th</sup> November, 2017 and the second hearing held on 29<sup>th</sup> January, 2018, when the following were present:-

Vihar was registered and accused persons KUndan & Chandan were arrested. NO role of HC Sanjay found in the matter. On 8.3.2017, the complainant handed over a complaint to the I.O. stated therein to add the section in his case regarding stolen his Rs. 35,000/- and gold ring by the accused. On receipt of the said complaint, section 380 IPC has been added in his case. After completion of investigation, the chargesheet has been prepared and filed in the Court on 1.11.2017. The case is pending trial in the court of Shri Manoj Kumar, MM, Tis Hazari Court, Delhi and the next date of hearing is 9.2.2018."

#### 4. Directions of PGC

Since the case is pending trial in the Court, the case has become subjudice, therefore, the Commission has decided to close the case in PGC with the advice to the complainant to puruse his case in the concerned court.
