Since the parties involved in these Appeals are common, various Appeals (06 in numbers) are being clubbed together for hearing and disposal to avoid multiplicity of the proceedings and effective adjudication.

1 Background :

The appellant vide his DRTI applications had sought information on total 20 points each. Aggrieved by non-receipt of information from the Competent Authority, he filed these appeals.

2. Proceedings

The appellant is not present. Sh. Vinod Bansal, Asstt. Engineer, (Bldg.), City/SP Zone, North DMC is present on behalf of the Competent Authority. He has filed point-wise replies dt. 22.12.2017/28.8.2018, duly signed by the Competent Authority in the Commission today.

The reply provided to the appellant has been perused and it is observed that the department has furnished satisfactory reply to all the queries, except query no.0 2 and 04.

In query no. 02, the appellant is seeking action taken report on his complaint submitted in the department on various dates. The appellant has mentioned specific diary numbers and dates on which he had submitted the complaint in the department. In response the department has given vague and unsatisfactory replies.

In query no. 04 the appellant has sought information about sanctioned building plan in respect of the properties mentioned in his DRTI application. The department has replied that no building plan has been sanctioned by this department. This reply is deemed not satisfactory since the period for which the record has been checked by the department has not been mentioned.

3 Decision

Since, the Competent Authority viz. Dy. Commissioner City/SP Zone, North DMC has furnished satisfactory replies to the queries of the appellant except for queries nos. 02 and 04, no further action is required to be taken on queries no. 01, 03 and 5 to 20.

The Competent Authority viz. Dy. Commissioner City/SP Zone, North DMC is directed to furnish a revised reply in respect of query nos. 02 and 04 as discussed above. The revised reply should be furnished within 2 weeks of issue of this order under signature of the Competent Authority, with a copy marked to this Commission for information.

With the above direction, the matter is accordingly disposed of at the Commission's end.
