1. Brief facts of the complaint

Sh. Vinod Kumar Gupta filed a complaint / grievance in this Commission against NDMC for not granting the benefit of Promotion to the post of Jt. CAO / FA on seniority basis.

3. Relevant facts emerging during the hearing

3.1 During the hearing on 07.05.2018 it is informed by the Jt. Director (Estt.), NDMC submitted a report stating that :

In the said context, it is worth mentioning that Sh. Vinod Kumar Gupta, Ex. Joint FA/CAO has already filed Court Case in the Central Administrative Tribunal, Principal Bench, New Delhi (MA No.767/2018 dt. 16.02.2018 in OA No. 4429/2017 dt. 28.11.2017) with the demand to grant the benefit of promotion w.e.f. 31.10.2014 i.e. the date on which his junior namely Shri Sunil Sharma was promoted as Joint FA / CAO.

The matter is sub-judice in the Central Administrative Tribunal and the next date of hearing is 31.07.2018.

The issue involved has larger ramification for other similarly placed officer in NDMC. The file is under process in consultation with Law Department of NDMC.

Thus, in view of aforesaid NDMC at present is not in position to give any Action Taken Report to Public Grievances Commission.

As the matter is sub-judice in the Central Administrative Tribunal, Public Grievances cannot entertain the matter at this stage, the same stands closed at the level of PGC.
