1. Brief facts of the complaint

The complainant has filed a complaint against Delhi Police of favouring the accused, inaction removing evidence from the file and connivance with the accused persons. He has stated that a complaint regarding playing laud music was made on 22.3.2016 regarding which two police personnels visited his house for enquiry. The visiting police personnel warned the alleged persons not to play laud music. He has further stated that his father made a PCR call at No. 100 regarding attack on him with knife and attacked on his private parts by the mother of one Prasoon. But the ASI Rajinder Kumar instead of taking action on the complaint favoured the alleged and pressurized his brother and mother. He has also stated that ASI Rajinder Kumar did not include the name of Proon's mother in the FIR and also removed the photographs /evidence from the file. He has stated that the police is connived with the alleged persons. He has requested for legal action in the matter.

1. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 28th February, 2018, the second hearing held on 28th March, 2018, the third hearing held on 18th April, 2018, the fourth hearing held on 23rd May, 2018 and the fifth hearing held on 13th June, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

The complainant alongwith his father is present. He reiterated the allegations as mentioned in

his complaint. He further alleged that police has favoured the accused by removing evidence

from the file and connivance with the accused persons.

4. Directions of PGC

Neither any MLC has been issued by any government hospital nor any X-ray has been submitted to

the police alongwith the complaint in support of the allegations. Even the private doctor has not

given any opinion regarding nature of injuries.

As per the record placed in the file, the case has been chargesheeted and the names of the alleged

accused have been mentoned in the chargesheet. The complainant, if he so desires can raise the

matter at the time of framing of charges by the Hon'ble Court.

Taking into account the submissions of the parties concerned and proceedings recorded during the

course of hearing, the Commission feels that the matter relates to dispute between the neighbours

over trivial matters involving playing of loud music. Such matters should, infact, be resolved by the

parties themselves without taking recourse to the police. Further, considering the alleged police

indifference to the contentions of the complainant, Shri Joginder Joon, SHO/Palam Vihar present on

18.6.2018 before the Commission is advised to brief the staff to handle such matters with due

sensitivity. SHO/Palam Vihar to give a hearing to complainant in the next week, regarding allegations

of removal of photographs/evidence from the file so that his confidence in police functioning is

restored.

With the above advice, the matter stands closed in the Commission.
