### **1. Brief facts of the complaint**

The complainant has filed a complaint of inaction against PS Aman Vihar on her complaint of alluring of her daughter, aged 17 years. She has stated that her minor daughter was allured by Kishan Lal and Kishore on 20.1.2018 and objectional photos of her daughter have been uploaded on Face Book, for which information/complaint was made at PS Aman Vihar. She has further stated that inspite of her repeated visits at the PS, no satisfactory action has been taken by the police. She has expressed her apprehension of some untoward incident with her daughter. She has requested for legal action in the matter.

### **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 7th June, 2018, when the following were present:-

### **3 Relevant facts emerging during the hearing**

An ATR has been filed by HC Jai Bhagwan, Vigilance Branch/Outer District, stating that the enquiry into t he matter was got conducted through ACP/PG Cell/OD which reveals that:-

On 20/1/2018 at about 7.30 p.m., the daughter of complainant namely Tarana @ Muskan, aged 17 years old was kidnapped by alleged persons namely Kishan Lal and Kishore. Statement of complainant Smt.

Yasmin was recorded and after examination, a case FIR No. 51/18 dated 21/1/2018 u/s 363 IPC PS Aman Vihar was registered.

During investigation victim was recovered and produced before CWC. CWC handed over custody of victim to her parents on 15.2.2018.

Further 366/376/506/34 IPC & POCSO Act were added into the said case during the course of investigation. Accused Kishan Lal was arrested on 20/2/2018 and sent to JC. However, Kishore availed anticipatory bail on 15.2.2018.

MTP of victim was got conducted on 9.3.2018 at SGMH, Mangolpuri and exhibits sent to FSL Rohini for examination.

As per report, a proper police action is taken and the case is under investigation.”

#### **4. Directions of PGC**

**The police representative has filed a copy of order of ASJ-01/Special Court-POCSO/NW/Rohini dated 29.5.2018 vide which “ the accused has been issued a strict warning for uploading the objectionable photographs of the complainant’s daughter on Face Book disposing off the application for cancellation of bail”.**

**The police representative further stated that Investigation in the instant matter has been concluded and the same will be submitted in the court when it re-opens after vacation.**

**In view of the above, the Commission has decided to close the case in PGC.**
