1. <u>Brief facts of the complaint</u>

3.2 Shri Jai Sharma, JSA, Education Department, Karol Bagh Zone has attended the hearing and submitted a report stating that the period of leave without pay of the complainant cannot be considered ambit of rule 21 of pension which necessarily requires a Medical Certificate, which she never tendered till her retirement on 31.03.2001.

4. <u>Directions of the PGC</u>

As per the report submitted by the Education Department, Karol Bagh Zone, North DMC it seems that the complainant has approached different forums and her case was considered and rejected on number of times on merits by the concerned departments.

Keeping in view the submissions at para 3.2 made by the Department it appears that no new fact has been brought by the complainant to reconsider her case hence the matter stands closed at the level of PGC.
