1. Brief facts of the complaint

The complainant has filed a complaint that his mother daughter has been lured/abducted by his neighbour Yogesh @ Lala on 6.3.2018. A case has been registered vide FIR No. 0185/18 u/s 363 in PS Aman Vihar, but IO of the case Inder Kumar is not taking any legal action. He has doubt that IO has taken money from the alleged party to save him. The complainant has requested for legal action in the matter.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has convened three hearings since 28.6.2018. At the latest hearing held on 20.9.2018, the following were present :-

3. <u>Relevant facts emerging during the hearing</u>

3.1. ATR filed by SHO/Aman Vihar through ASI Inder Kumar is on record.

3.2 ASI Inder Kumar from PS Aman Vihar is present and submitted that accused Yogesh @ Lala has been arrested on 14.9.2018 and running in JC till 28.9.2018. Victim has also been recovered. Statement of victim u/s 164 Cr.P.C. has also been recorded by the Hon'ble Court. He further stated that victim has married with the accused on 10.9.2018. The complainant is not co-operating in the investigation. He also stated that custody of victim was given to the father in law of victim by the members of CWC. Chargesheet of the case will be finalized soon.

4. Directions of PGC

4.1 Complainant is not present. He has not attended any of the four hearings held in the Commission so far.

4.2 Complainant is directed to co-operate the IO to enable him to conclude the investigation expeditiously.
