### **Background**

The appellant vide his 6 (six) DRTI applications had sought information on 20 (twenty) counts. Aggrieved by non receipt of information, he filed the present appeals.

Reply perused. The Competent Authority has furnished the reply / information in most of the queries raised by the appellant. However, some of the replies are sketchy and does not specify action taken under the DMC Act.
