## 1. Brief facts of the complaint

The complainant has filed a complaint alleging that SI Rajeshwar pressurized her to provide water connection to her neighbour Mrs. Sunita and assured to distribute the expenditure between two. On his assurance she applied for new water connection and spent approximately Rs. 10,000/- but later her neighbour did not pay the 50% expenditure incurred for new water connection and SI Rajeshwar did not take any action in this regard. The complainant has requested for legal action in the matter.

The matter has been settled amicably between both the parties.
