1. Brief facts of the Appeal

Shri Harish Vats filed Form-A during November, 2017 under the Delhi RTI Act, 2001 with the Competent Authority i.e. Deputy Director of Education (North West-A), Directorate of Education, making queries on total 2 counts.

Shri Harish Vats did not receive a reply from the office of Deputy Director of Education (North West-B), Directorate of Education, hence, he filed an Appeal during January, 2018, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. Proceedings in the Public Grievances Commission

The PGC has so far convened two hearings on 26th March, 2018 and 23rd April, 2018. At the hearing on 23.04.2018, the attendance was as follows :

3.2 The reply furnished by the department has been perused and it is found that the department has provided satisfactory information to the queries raised by the appellant in his DRTI application.
