1. Background:

Sh. Manoj Kumar Sharma, the appellant vide his application dated 26.05.2017 under Delhi Right to Information Act, 2001, had sought information from the Deputy Commissioner (Karol Bagh Zone), North DMC / Competent Authority notified under the DRTI Act-2001 on total 06 queries.

The appellant did not receive any information from the Competent Authority i.e. Deputy Commissioner (Karol Bagh Zone), North DMC. Being aggrieved with the same, he filed the appeal before the Appellate Authority, Public Grievances Commission.

2. Proceedings

The appellant is present and heard.

None appeared on behalf of the Competent Authority.

On perusal of appeal record, it is revealed that a letter dated 11.04.2018 signed by Ex. Engg (B), Karol Bagh Zone, has been sent to appellant stating therein that a reply has been sent to the appellant on 06.07.2017. Further, it has been mentioned in the letter that action has been initiated and the property has been booked vide letter dated 19.07.2017 and demolition order passed on 10.08.2017. It has been further informed vide letter that the Subhadra Colony area was transferred under the jurisdiction of City Sadar Pahar Ganj Zone and original booking file was sent to City S.P. Zone on 08.09.2017.

3. Decision:

The appellant is seeking information regarding his complaint against unauthorized construction at A-139 & A-140, Subhadra Colony.

Since the department had provided information regarding action taken against the said property vide letter dated 11.04.2018, no further action is required in the matter.

Further, as informed by the department, the appellant is advised that to know further action in the matter, he may file a fresh application under DRTI Act-2001 in the office of Deputy Commissioner (City S.P. Zone)

The matter is accordingly closed at the Commission's end.
