### 1. Background:

Sh. S.C. Yogi, the appellant vide DRTI application dated 03.08.2017 has sought information from the Deputy Commissioner (Narela Zone), NDMC / Competent Authority notified under the DRTI Act-2001, on total 04 counts.

The appellant did receive the information from the Competent Authority. However, being aggrieved with the same, he filed an appeal before the Commission.

#### 2. Proceedings

The appellant is not present.

None appeared on behalf of the Competent Authority. Reply dated 25.08.2017, furnished to the appellant has been perused. Since the reply has not been signed by the Competent Authority, the same is unacceptable.

In respect of Query No. 1 & 2, specific and detailed information, as asked by the appellant, should be provided.

In respect of Query No. 3, details of fees for obtaining various licences should be provided to the appellant. Further regarding license policy, details of each stage to obtain the information from the Website should be provided.

In respect of Query No. 4 office address and phone number of the officers should be provided.

In respect of Query No. 5, details of each stage to obtain the information from the Website should be provided.

#### **Decision**

The Competent Authority is advised that the information sought by the appellant regarding name, designation, address, phone number, nature and jurisdiction of work in respect of officers / officials of the department can be made available on the

official website of the department, so that any applicant can access the same. Such initiative by the department will reduce the number of applications under DRTI Act seeking such information. It is pertinent to mention here that as per Section 4(b)(i), it is obligatory on the authorities to public the particulars of its organization, functions and duties.

The Competent Authority i.e. Deputy Commissioner (Narela Zone), North DMC is directed to furnish a revised reply, as discussed above, within 2 weeks from the date of receipt of this order, directly to the appellant, with a copy marked to the Commission under his signature / stamp.

The matter is accordingly closed at the Commission's end.
