### **1. Background :**

Sh. Naveen Kumar, the appellant vide his application dated 24.02.2018 under Delhi Right to Information Act, 2001, had sought information from the Secretary, DSSSB/Competent Authority notified under the DRTI Act-2001 on total 19 queries.

The appellant did not receive any information from the Competent Authority i.e. Secretary, DSSSB. Being aggrieved with the same, he filed the appeal before the Appellate Authority, Public Grievances Commission, as provided under Section 7 of DRTI Act -2001.

### **2. Proceedings**

The appellant is present and heard.

Shri A. Matin, representative of the Competent Authority, states that the information had already been furnished to the appellant vide letter dated 18.05.2018. The appellant submitted that he is not satisfied with the information. The reply perused.

### **3. Decision :**

The appellant is seeking information regarding written pre-exam for the post code 88/14 Publicity Assistant (MCD).

On perusal of the reply, it has been revealed that the same has not been signed by the Competent Authority, as required under Delhi Right to Information Act, hence unacceptable.

Further in respect of Query Nos. 1, 5, 12, 16, 17, 18, 14 and 15, the department informed that the information asked is related with Interview Cell and I.T. Branch, for which the RTI has been transferred to related branches.

**The matter is brought to the personal attention of the Competent Authority i.e. Secretary, DSSSB.**

It is incumbent upon the Competent Authority to collate the requisite information from concerned offices under his administrative control and provide comprehensive reply to the appellant

He is hereby directed to furnish a revised point wisereply to the queries of the appellant within 7 days from the date of issue of this order, directly to the appellant with a copy marked to the Public Grievances Commission under his own signature, properly stamped, having the name of Competent Authority.

**The matter is accordingly closed at the Commission's end.**
