1. Brief facts of the Appeal

Shri R. L. Makhija filed Form-A during November, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Engineer-in-Chief, North DMC, seeking information on total 16 counts.

Shri R. L. Makhija received no response from the Office of Engineer-in-Chief, North DMC. Hence, he filed an Appeal during December, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. Proceedings in the Public Grievances Commission
