**1. Background :**

Sh. Rinku, the appellant vide DRTI application dated 07.04.2017 has sought information from the Deputy Commissioner (City SP Zone), North DMC / Competent Authority notified under the DRTI Act-2001, on total 05 counts.

The appellant did not receive any information from the Competent Authority i.e. Deputy Commissioner (City SP Zone), North DMC. Aggrieved by the same, he filed an appeal before the Appellate Authority, Public Grievances Commission under Section 7 of DRTI Act -2001.

**2. Proceedings**

The appellant is not present.

Shafique Ahmed AE, City SP Zone, North DMC is present on behalf on the Competent Authority, but no reply has been submitted.

The Commission notes that non submission of pointwise and comprehensive reply by the Competent Authority i.e. Deputy Commissioner (City SP Zone), North DMC to the information sought by the applicant under DRTI Act 2001 amounts to denying information to the applicant and causing deliberate obstruction in the flow of information.

**3. Decision**

**The matter is brought to the personal attention of the Competent Authority i.e. Deputy Commissioner (City SP Zone), North DMC.**

**He is directed to furnish the relevant information directly to the appellant within 2 weeks of issue of this order, under intimation to the office of this Appellate Authority / PGC.**

**The reply should be furnished to the appellant under the signatures of Competent Authority, duly stamped, having the name of Competent**

**Authority. Documents, if any, to be appended with the reply should be certified either by the Competent Authority or an official deputed by the Competent Authority.**

**The appeal stands disposed with the above direction.**
