### **1 Background :**

Sh. Mahendra K. Khattar, the appellant vide DRTI application dated 19.3.2018 has sought information from the Competent Authority notified under the DRTI Act-2001, on total 05 points

The appellant did not receive any information from the Competent Authority i.e. the Director (Personnel), North DMC. Hence, he filed an appeal before the Appellate Authority, Public Grievances Commission under Section 7 of DRTI Act -2001.

### **2 Proceedings**

The appellant is not present. The representative of the department submitted a copy of the reply signed by Sh. Pankaj Kumar Sharma, PIO (CED). The same is not in order as per the provisions of DRTI Act 2001.

### **3 Decision**

**A perusal of the record reveals that the application for seeking information was submitted to the Competent Authority on 31.1.2018 and the information was furnished to the appellant only on 4.4.2018 i.e. after lapse of over 02 months. Even this information is not satisfactory and has not been signed by the Competent Authority.**

**The Competent Authority i.e. The Director (Personnel), North DMC is hereby directed to furnish the point-wise reply to the queries of the appellant within 10 days from the date of issue of this order, directly to the appellant, with a copy to the Appellate Authority for information.**

**The reply should be furnished to the appellant under the signatures of Competent Authority, properly stamped, having the name of Competent Authority (documents, if any, appended with the reply should be certified either by the Competent Authority or an official deputed by the Competent Authority, free of cost.**

**With the above directions the present appeal case is ordered to be closed in the Commission.**
