1. Brief facts of the case

1.1 Sh. Shekhar Saxena filed a complaint in PGC on 31.5.2018 regarding excessive

delay in sending cases of pension revison of pre-2016 retirees and payment of

arrears of Leave Encashment.

2. Facts emerged during the proceedings.
