1. Brief facts of the complaint

The complainant has filed a complaint stating that her daughter Rubina has been missing since 22.11.2016. Her daughter was working in jean factory in Shahabad Daulatpur. She informed the police about missing of her daughter as well as the name of the persons (Asha, Akash, Lallan and Poonam) who were involved in the missing of her daughter but police did not take any action on her complaint. She further alleged that she made a call at NO. 100 and informed about the Lallan but police made him (Lallan) free after taking bribe. IO of the case SI Satish Chander took her signature on FIR. She also stated that one Ishawr made a call from the number 7685854935 at her number and informed her that her daughter is in Bihar and her daughter also talk to her. She also informed the police about this. She stated that Police is not taking any action on her complaint.

2 Relevant facts emerging during the hearing

2.1 SI Neeraj Kumar, PS S.B. Dairy presented action taken report and the same has been taken on record and is placed in the file. SI Neeraj Kumar further stated that several raids were conducted to trace out the landlord Vinod Yadav, who gave his house on rent to the alleged persons, but he was not found present at his home. The CDR of mobile number 7685854935 has been analyzed but as per the CDR no conversation has been held between the complainant and the given number. As per CAF the owner of the said mobile was Sabita Bairagi, r/o Ward NO.2, Joginder Nath Colony, Tehsil Kalyani, Distt. Nadia, West Bengal. He visited the place in West Bengal and examined her. He stated that she was in possession of the said mobile number but she lost it one year ago. However, she did not lodge any complaint in this regard in any police station. Further, there is no clue found about the missing girl and accused persons. He also submitted that the previous IO of the case SI Satish Kumar has retired from service. The case is pending investigation.

2.2 The complainant has not attended any of the seven hearings held in the Commission so far.

3. Directions of PGC

- 3.1 The present IO SI Neeraj Kumar, PS S.B. Dairy has made all possible efforts to trace the missing girl child including visit to West Bengal to examine Sabita Bairagi. He has stated that the complainant is an illiterate lady and has shown her ignorance regarding the allegations of having talked to her missing child through mobile no. 7685854935.
- 3.2 In view of the above, it is appropriate to transfer the investigation to AHTU, the specialized body to investigate it further from trafficking point of view since the missing child is grown up age of 17 years and possibilities of her trafficking cannot be ruled out.
- 2.3 With the above advice, the Commission has decided to close the case in PGC.
