Since the parties involved in the Appeals are common, both the Appeals are being clubbed together for hearing and disposal to avoid multiplicity of the proceedings and effective adjudication.

#### **1** Background :

The appellant vide DRTI application dated 16.10.2017 has sought information on total 15 points each. Aggrieved by non receipt of any information from the Competent Authority, he filed these instant appeals.

### 2 Proceedings

The appellant is present. No one is present on behalf of the Competent Authority. However, a copy of reply dt. 12.3.2018, duly signed by the Dy. Commissioner, KB Zone, North DMC vide which point wise replies to the queries of the appellant have been furnished is available in both the appeal files. The replies have been perused.

The appellant submits that he is satisfied with the information furnished to him by the department, except for point no. 15. Vide point no. 15 the appellant has sought information regarding name of the institute with complete details from where Sh. Deepak Kumar Junior Engineer and Sh. Parkash Arya, Junior Engineer have done their diploma course in Engineering.

The Appellate Authority observes that the information provided by the department is not satisfactory. The Competent Authority viz. Dy. Commissioner, Karol Bagh Zone shall furnish a revised reply clearly informing the name, place of the institute and year of passing and also whether both the officials have pursued their course on regular basis or through distance education. The appellant has alleged that most of the officials have

obtained their degree/diploma through distance learning, which would render them ineligible for this post.

# **3 Decision**

The Competent Authority i.e. Dy. Commissioner, K.B. Zone, North DMC has furnished satisfactory replies to the queries of the complainant, except for query no. 15. The Competent Authority shall furnish a revised reply, in both the appeal cases, as discussed above directly to the appellant within 15 days f issue of this order with a copy endorsed to this Commission. The revised reply must be issued under the signature/stamp of the Competent Authority.

With the above directions, the matter is accordingly disposed of at the Commission's end.
