1. Brief facts of the complaint

1. Shri Satya Narain filed a complaint vide Regn. Number GNCTD/E/2018/02766

regarding revision of pension of pre-2016 pensioners /family pensioners.

2. Facts emerged during the proceedings.

2.1 Head of School, Govt. Sarvodaya Bal Vidyalaya, Radhey Shyam Park, filed an ATR

giving break up of the retirement benefits vis. DCRG, Commutation, Leave Encashment,

Group Insurance, Diff of E/Leave and Stepping of Pay which has been paid to Shri Satya

Narain, complainant.

2.2 Another ATR dated 5.11.2018 has been filed on behalf of Dy.Director of

Education (East), GNCT of Delhi, stating that pension of Shri Satya Narain has been

revised on 26.9.2016. The complainant has himself admitted that there is no such

grievance still pending in the School.

2.3 During the proceedings, Shri Satya Narain, complainant, has given a letter stating that his grievances relating to all the pensionary benefits have been resolved completely and no claim is pending against the HOS, GSBV, Radhey Shyam Park.

## 3. <u>Directions</u>:

3.1 In view of the action taken by the Department in releasing his pensionary benefits and the complainant confirming the same in the PGC today as well as given in writing to close the case as no claim is pending against the School, the case of the complainant is disposed in PGC.
