### 1. Brief facts of the complaint

Engineer (M) III, Central Zone, SDMC is present in the hearing and submitted a report stating that the work of maintenance in unauthorized colony i.e. Sangam Vihar, AC-49 does not pertain to SDMC and the same has been assigned to DSIIDC vide note dated 09.11.2017 of Hon'ble Minister of Power, PWD, UD, Health, Industries & Home, Govt. of NCT of Delhi.

### 4. <u>Directions of the PGC</u>

- 4.1 Action on the part of SDMC is complete and hence the initial grievance of the complainant has been resolved.
- 4.2 Shri Arun Mishra, Executive Director, DSIIDC is advised to take note of the submissions of the complainant that there are encroachments in the form of toilets, water tanks with structures etc. on govt. land in Sangam Vihar, initiate action and submit an Action Taken Report to this Commission.
- 4.3 With the above directions in the matter the case stands closed at the level of PGC.
