### **1 Background :**

The appellant vide DRTI application dated 27.3.2018 has sought information on total 22 points each. Aggrieved by the information provided to him by the Competent Authority, he filed these instant appeals.

### **2 Proceedings**

The appellant is present. Sh. Suresh Dua, AE (Bldg.) CL Zone is present on behalf of the department. The representative of the department informed that point wise replies have already been sent to the appellant vide deptt. letter dt. 17.4.2018. A copy of the same is available in each of the appeal files.

The reply of the department has been perused. The department has informed that the information sought by Sh. S.C. Bhaskar is voluminous and not available in a consolidated form. Further the department has requested the appellant to visit room no. 204/311, in the office of the Dy. Commissioner, CL Zone on any working day and inspect the available record.

shall be made available to him on payment of requisite fees as prescribed under the DRTI Rules 2001.
