## 1 Background:

The appellant vide DRTI application dated 12.6.2018 has sought information on total 06 points. Aggrieved with non receipt of any information from the Competent Authority, he filed this appeal.

#### 2 Proceedings

The appellant is present. Sh. S. D. Bhardwaj, CLI-I and Sh. Basanta, LI, KP Zone, North DMC are present on behalf of the Competent Authority. The representatives of the department have furnished a reply dt. 19.11.2018 (in duplicate), a copy of which was given to the appellant during the hearing.

The reply of the department has been perused. Although it appears that the department has provided satisfactory information to the queries of the appellant but the action taken by the department to remove vehicles parked unauthorisedly in the area is not adequate. A more stringent and effective encroachment removal action should be undertaken by the department on regular basis.

Further, in another appeal case, it has come to the knowledge of the Commission that - "as per record building plan of plot no. 05, Printing Press Complex, Wazirpur Industrial Area having plot area 945 sq. mtr. was sanctioned vide file no. 13/A/HQ/2001 dt. 24.1.2001 in the name of Jan Seva Trust. Building Plan of plot no. 06, Jan Seva Trust, Printing Press Complex, Wazirpur Industrial Area having plot area 874 sq. mtr. has been sanctioned vide file no. 14/A/Hq./2001 dt. 24.1.2001 in the name of Jan Seva Trust". But the Factory Licensing Department, North DMC has issued Factory License to M/s DD Motors in Plot no. 05 and 06 for automobiles service and repair workshop.

The above fact is brought to the personal attention of the Dy. Commissioner, (Factory License) North DMC to verify if there is any violation of provision of lease under which the Building Plans of these plots were sanctioned in the name of Jan Seva Trust.

#### 3 Decision

Since the department has provided satisfactory reply to the queries of the appellant, no further action is required to be taken by the department on these points. However, the Dy. Commissioner, K.P. Zone North DMC is advised to undertake more stringent action for removal of vehicles parked unauthorisedly in the area, as advised above.

Further, in another appeal case, it has come to the knowledge of the Commission that - "as per record building plan of plot no. 05, Printing Press Complex, Wazirpur Industrial Area having plot area 945 sq. mtr. was sanctioned vide file no. 13/A/HQ/2001 dt. 24.1.2001 in the name of Jan Seva Trust. Building Plan of plot no. 06, Jan Seva Trust, Printing Press Complex, Wazirpur Industrial Area having plot area 874 sq. mtr. has been sanctioned vide file no. 14/A/Hq./2001 dt. 24.1.2001 in the name of Jan Seva Trust". But the Factory Licensing Department, North DMC has issued Factory License to M/s DD Motors in Plot no. 05 and 06 for automobiles service and repair workshop.

The above fact is brought to the personal attention of the Dy. Commissioner, (Factory License) North DMC to verify if there is any violation of provision of lease under which the Building Plans of these plots were sanctioned in the name of Jan Seva Trust.

An Action Taken Report shall be submitted in the Commission for perusal within 04 weeks of receipt of this order.

With the above directions, the present appeal case is ordered to be disposed of in the Commission.
