### **1 Background :**

The appellant vide DRTI application dated 4.4.2018 has sought information on total 08 points. Aggrieved with non receipt of any information from the Competent Authority , he filed this appeal.

### **2 Proceedings**

The appellant is present. Sh. Diwan Singh, FSO, F&S department is present on behalf of the Competent Authority. The representative of the department informed that the appellant has already been provided point-wise reply by the department vide letter dt. 09.4.2018. He submitted a fresh reply dt. 15.11.2018.

All the replies of the department have been perused and it is observed that the initial reply provided to the appellant vide letter dated 9.4.2018 is not signed by the Competent Authority and also the information provided in respect of query nos. 4 to 08 is not satisfactory. It is brought to the attention of the Asstt. Commissioner (Central District), being the Competent Authority, that it is incumbent upon him to collect the relevant information from all the branches/offices functioning under him and provide a comprehensive point-wise information to the appellant under his signature. Sh.Wahid Khan the appellant submitted that he may be allowed to inspect the relevant record and thereafter he can obtain photocopies in respect of query no. 04 to 08. The departmental representative and the appellant mutually agreed for inspection of the records on 26<sup>th</sup> Nov. 2018 at 4.30 PM in the office of the Asstt. Commissioner, Central District, F&S Department.

### **3 Decision**

Since the department has provided satisfactory information to the appellant in response to his query, except for query nos. 04 to 08, no further action is required to be taken by the department.

In respect of query nos. 04 to 08 the Competent Authority viz. Asstt. Commissioner, (Central District) is directed to accord inspection to the appellant on the date and time mutually agreed upon. Thereafter photocopies of documents, if any, identified

by the appellant shall be made available to him on payment of requisite fee as prescribed under DRTI Rules 2001.

With the above direction the present appeal case is ordered to be disposed of in the Commission.
