1. Brief facts of the complaint

The complainant has filed a complaint against the police officials of PS Jahangir Puri to intimidate him, deleting the recordings of the DVR covering the incident of attempted theft of his car. He has stated that on 15.10.2017 around 1.30 a.m. some boys were peeping through his SUV vehicle. On his objection they misbehaved with him and started manhandling him. Police was informed at No. 100 but instead of taking legal action against the said boys SI subhash visited complainant's house on 16.10.2017 and advised him to forget the incident and also deleted the recording of the incident in CCTV and also threatened of dire consequences if any complaint is made in this regard. He has requested for legal action in the matter.
